- We will effectively implement change management, taking into account maintenance, repair and temporary shutdowns and commissioning operations,
- We will implement emergency plans and increase our effective response capabilities by conducting necessary drills,
- We will effectively implement work, process and environmental accident investigation and near-miss processes and ensure that necessary corrective actions are taken and followed up,
- We will prioritize continuous review and improvement in all of the above-mentioned issues by evaluating the security management system,
